13:45 Session II Constructive engagement with national actors

National ownership is a driving principle in many aspects of international assistance to national actors. Yet national actors are heterogeneous and multiple stakeholders with varying, often divisive and competing needs. Constructive engagement with national actors is aimed at supporting processes of democratic change when some actors are change champions and others spoilers.

- In order to support completion of successful processes of constitution building, such as in South Africa, how have diverse international actors responded to the needs and priorities of different national actors vis-à-vis the needs of the process and the country situation?
- How do external actors determine which actors to engage, when and on what basis?
- When has international engagement been unhelpful for national actors?
- Can good practices in engagement approaches be discovered and shared?
- How has international engagement in constitution building differed from international assistance for development and democracy building?

09:00 Session III Inclusion of marginalized groups

Contesting groups in constitutional processes wield asymmetrical power. Some groups are marginalized due to these imbalances in power, e.g. women, minorities and victims of conflict and may be sidelined during the substantive negotiations over the process of constitution building. The risk is that involvement of international actors can intensify power asymmetry and thereby, marginalization.

- Should the risk of marginalization inform how, when and where international actors engage?
- How can international actors help to expand political space for marginalized groups?
- How do international actors strike the appropriate balance between promoting equality and respecting autonomy? What is the impact and material outcome of these efforts?
