Arachapon Nimitkulpon (Thailand)

Arachapon Nimitkulpon has been working in a human rights organization since 2008 after obtaining a Political Science degree from Thammasat University. She started her career as an intern at Forum-Asia, a regional human rights organization based in Bangkok, wherein she focused on the human rights issue of Burma and Thailand. She was later assigned in the southern border of Thailand where there is an ongoing violent-conflict and many human rights abuses. She then worked with the peace group for one year under the project called "Peace Witness Volunteer". After that, she became a local coordinator of Protection International, an international human rights organization working under the pilot project "security and protection training for human rights defender". The project aims to strengthen the capacity of HRD who facing threat and intimidation because of their work to be able to protect themselves, their colleagues, the witnesses and the villagers from any harm. At present, she is a project officer of the Working Group on Justice for Peace, a national human rights organization that mainly focuses on the work of human rights issue in the three southern border of Thailand but also do have other areas of work in other part of the country. They monitor the abuses, campaign to promote and protect human rights as well as strengthen the local people to know their rights and stand up to protect it.

Brian Barbour (Hong Kong)

Brian Barbour is currently serving as the Executive Director of the Hong Kong Refugee Advice Centre, a non-governmental organization that works to protect refugee rights, and strives to ensure all refugees in Hong Kong have access to high-quality legal aid, fair refugee status determination procedures, and human rights. Brian has worked in education, international development and refugee protection over the past 10 years in Japan, Nepal, Italy, the United States and Hong Kong. Brian received his Juris Doctor degree from Brooklyn Law School where he focused on international human rights and refugee law and policy. Brian is licensed and admitted to practice as an Attorney and Counselor-at-Law in the State of New York.

Catherine Ruiz (The Philippines)

Catherine M.A. Ruiz is the executive director of the Center for Participatory Governance (CPaG), a Cebu-based capability-building, resource center promoting active citizenship and participatory governance initiatives. She has served with the organization since its inception 10 years ago in various capacities as a member of its Board of Directors, Chairperson, and has been managing the organization since January 2008. She is a skilled marketing communications person and once managed a local advertising agency. She is an active

member of the political party, Akbayan Citizen's Action Party, formerly serving as division chairperson for Cebu City and as a representative to the party's national council for nine years. She is currently the vice-chairperson of Kaabag sa Sugbu, a network of 28 non-government, development organizations in Cebu.

Chalida Tajaroensuk (Thailand)

Chalida Tajaroensuk obtained her Bachelor's degree from Thammasat University and Master's degree from the National Institute For Development and Administration (NIDA). She has been working with Human Rights NGOs for more that 30 years. She started her human rights activity when she was a student in the university. She is currently the director of People's Empowerment Foundation (PEF). PEF was registered under the Thai law on July 2008. It was set up after the coup 19 September 2006. They have 4 main projects, namely Grassroots Democracy, ASEAN people's project, Southern Thailand project and Cross border project.

Chameera Perera (Sri Lanka)

Chameera Perera's origins were very much political. He was born into a left family. His grand father was a strong character who was a pioneer member of Lanka Sama Samaja party (first Marxist party of Sri Lanka) and devoted his youth to the freedom struggle of the country. He started his sociopolitical life soon as he left school, the moment where the country was drawn to the vortex of despotism. He was inevitably engaged with the socio-political movement which enacted against the existed government of U.N.P. (United National Party). He successfully completed a master's degree with magna cum laude in modern history with a thesis of modernity, nation and besieging the nation state. He got an opportunity to join national anti war front as a project director which was the start of his professional career. Currently, he is a consultant at the center for society and religion, which articulates citizen forum network (already established 10 citizen forums in 10 districts in the country) to create common sense for the public to expose their actions and activities which would converge under the consent of democratic citizenship.

Herbin Siahaan (Indonesia)

Herbin Marulak Siahaan is an Indonesian Lawyer. He is the Executive Director of the Institute for Criminal Justice Reform (ICJR), which is based in Jakarta, Indonesia. He has a lot of experience in working in the field of Law Reform, Security Sector Reform, Peace Building, Counter Trafficking in Women and Children, Community Legal Service, Legal Empowerment, Human Rights, and Criminal Justice Reform. He has previously worked for some international organizations, i.e. International Committee of the Red Cross (ICRC), The Asia Foundation, International Criminal Investigative Training Assistance Program (ICITAP), and International Organization for Migration (IOM). He graduated from Satya Wacana Christian University in Salatiga Indonesia and obtained a Master's Degree in Criminal Law from Padjadjaran University Bandung Indonesia.

Joy Alcantara (The Philippines)

Joy Alcantara is a Doctor of Medicine, a staunch advocate of children's rights who joined politics to promote pro-child advocacies. A specialist in dermatology and geriatrics, she hops to and from Skincellance, an aesthetic clinic she owns, and Akap Bata (Embrace the Child), where she volunteers her services for children. She was chosen first nominee of Akap Bata Party List during the recently held Philippine elections in May 2010.

James Francis Lugtu (The Philippines)

James Francis Lugtu graduated from the Philippine Military Academy and is currently working under the Department of National Defence. His functional experience has been further enhanced by his able participation in international missions that are focused on human rights and international humanitarian law. One such mission is the Philippines' participation in the first-ever review session under the UN's Universal Periodic Review (UPR)

on April 11, 2008, in Geneva, Switzerland. Ltsg Lugtu was Observer and Special Technical Assistant to the Head of Delegation, then Executive Secretary Eduardo Ermita, who was also the chairman of the Presidential Human Rights Committee (PHRC). The UPR is a unique process which involves a review of the human rights records of all 192 UN Member States once every four years. Another mission which Ltsg. Lugtu was involved in was the consideration by the United Nations Committee Against Torture of the Philippines' 2nd to 5th Consolidated Report on the Convention Against Torture and Other Cruel, Inhuman, and Degrading Treatment and Punishment on April 28-29, 2009, at the said Committee's 42nd Session. Again, as Special Technical Assistant to the same Head of Delegation and Observer, Ltsg. Lugtu was involved in discussions in the technical working group convened by the Presidential Human Rights Committee Secretariat to prepare for the Country Report for consideration.

Jayampathy Wickramaratne (Sri Lanka)

Jayampathy Wickramaratne, P.C. counts over 32 years as a legal practitioner in Sri Lanka and specializes in constitutional law, human rights litigation, administrative law and criminal law. In 2001, he was appointed President's Counsel, equivalent to Queen's Counsel in England. He holds a Master's degree in Public Administration and was awarded a Ph. D. degree for his thesis titled "Fundamental Rights in Sri Lanka". He served as Consultant and Senior Advisor in the Ministries of Justice and Constitutional Affairs, Sri Lanka and was a member of the team that drafted the Constitution Bill of 2000. He was also a member of the panel of experts appointed by the President to service the All Party Representative Committee (APRC) and was a signatory to the "majority report" which proposed a strong power-sharing arrangement as a solution to Sri Lanka's ethnic crisis. Dr. Wickramaratne has done several assignments for UNDP, UNODC and Sida in Lao PDR relating to law reform, human rights, criminal justice, human trafficking, international law etc. He is a Director of the Institute for Constitutional Studies, a non-governmental organization working on constitutional issues including constitutionalism, devolution, power-sharing and human rights.

Khushee Tharu (Nepal)

Khushee Tharu has been working with International IDEA's Nepal Office as Constitution Building Coordinator since 2009. With LLM degree in constitutional laws, he is coordinating constitution building programme of Nepal office through national partners, constitutional experts, CA Secretariat and CA members as well as supporting CA caucuses and procedural committees including Public Opinion Collection and Coordination Committee. Previously, he worked in UN systems (UNMIN, OHCHR, UNDP) for four years until 2008 where he supported peace process in Nepal by monitoring Comprehensive Peace Accord between the Government of Nepal and CPN-Maoist 2006, Election Code of Conduct of CA election as well as public security environment favorable for CA election. He conducted investigation of human rights violation and abuses when working with the OHCHR/Nepal office. He practiced law for ten years in different courts of Nepal until 2001. Likewise he volunteered on social services in backward areas in Nepal.

Liza Maza (The Philippines)

Liza Maza has been a member of the Philippine Congress as representative of the party list "Bayan Muna" in 2001. From 2004 to 2010, she represents the Gabriela Women's Party, the biggest and strongest women's party in the country. She authored/co-authored legislations such as the Anti-Trafficking in Persons Act, the Anti-Violence Againts Women and Children Act, the Juvenile Justice Act and the Magna Carta of Women, among others. She has been a feminist activist for 23 years and for more than 30 years involved with the movement for social change in the Philippines. She has been a delegate to various United Nations conferences and invited to over 35 countries to speak about Filipino women, Oversease Filioino Workers (OFW) and the national situation. Like most mothers, she strives to balance her role as a social activist and public servant as well as mother to her two sons.

Margiyono (Indonesia)

Margiyono is a journalist-cum-lawyer. He studied law in University of Indonesia and holds a Bachelor of law. He works as journalist since 2003, focusing on law and human rights issues. He is the Advocacy and Legal coordinator of The Alliance of Independent Journalists, wherein he coordinates legal and policy advocacy for media in Indonesia. Their main objective is to develop constitutional and legal protection for press freedom in Indonesia. Their midterm goal is to encourage Indonesian parliament to include press freedom protection in Indonesian Constitution.

Mohamed Nizam Kariapper (Sri Lanka)

Mohamed Nizam Kariapper is an attorney-at-Law by profession and is the Deputy Secretary General of Sri Lanka Muslim Congress, a political party in Sri Lanka which has eight members in the present Parliament. He is also a member of Constitutional Committee of the party and represented the party at the All Party Representative Committee convened by the President to formulate constitutional principles for home grown new constitution for the country. He also holds a diploma for Conflict Resolution and Skills development awarded by UPEACE (University of Peace of UN) and Diploma certificate awarded by UPSALA University for Peace and Security. He is presently studying for his master of Laws Programme conducted by Faculty of Law of University of Colombo and is offering the subject of Administrative Law, Human Rights Law and International Humanitarian law. He had also held the post of State Counsel in the Attorney Generals Department of Sri Lanka and former member of Public Service Commission of Sri Lanka.

Muji Kartika Rahayu (Indonesia)

Muji Kartika Rahayu is a public lawyer and social activist, who is involved in human rights and corruption issues. She works as Deputy of Chair at the National Consortium for Legal Reform, a NGO in Indonesia that is formed in 1998. They follow the developments of the Indonesia constitution amendment moment. While the house of representative revised constitution, they led civil societies participation by drafting constitution public version then endorsed it to the house of representative. After the amendment was finished, next civil society participation is drafting a Law on Constitutional Court and creating an excellence Constitutional Court by designing a blue print of Constitutional Court. Lastly, when the Constitutional Court is established, the National Consortium for Legal Reform's concern is exercising the Constitutional Court to defend citizen constitutional right such as Law on Truth and Reconciliation Commission, article about defamation, etc. It happens that the NGO gets disappointed with Constitutional Court's verdict. Right now, they are advocating the legislation and establishing anti corruption Court as a follow up to the Constitutional Court. decided in 2006. Besides working in National Consortium for Legal Reform, Muji is also a volunteer in solidarity committee for Munir, who was a human rights activist who died on board to Amsterdam, 7th September 2004.

Nattapat Lertprapotekul (Thailand)

Nattapat Lertprapotekul has been working with FORUM-ASIA since October 2008 as an intern for Human Rights Defenders Programme. He continued his work in FORUM-ASIA as the Human Rights Defenders Fellow in the beginning of 2010. Apart from his human rights work at FORUM-ASIA, Nattapat Lertprapotekul is also studying for the Masters of Laws at the Faculty of Law, Chulalongkorn University. He takes a major in international law.

Paisarn Likhitpreechakul (Thailand)

With support from Thailand's National Human Rights Commission, Paisarn translated into the Thai language the Yogyakarta Principles on the Application of International Human Rights Law in relation to Sexual Orientation and Gender Identity. The document was used by LGBT activists in their meetings with the Constitution Drafting Assembly in 2007 to guarantee equality for LGBT Thais. Since then, he has also been actively involved in LGBT movement building, working with the NHRC, HIV/AIDS non-government organizations and individual

LGBT activists. In addition to his gay column which first appeared in the English-language newspaper The Nation in 2002, he also writes opinion pieces on LGBT-related issues and Buddhism.

Paolo Romero (The Philippines)

Paolo Romero started working as a police reporter in 1996 with The Philippine STAR newspaper and covered various beats and foreign events, including conflicts as well as international forums. He also covered three Philippine presidents, all of whom pushed for amendments to the country's constitution. He is also active in promoting press freedom in the Philippines, considered to be one of the world's most dangerous places for journalists. He is the President of the Malacanang (Office of the President of the Philippines) Press Corps, and member of the National Press Club and the Defense Press Corps.

Purna Man Shakya (Sri Lanka)

Purna Man Shakya is a constitutional lawyer with varied experience in constitutional law. He did his higher education from Delhi University and then from Columbia University at New York. He holds Masters' degree from Faculty of Law in Delhi (GOLD MEDALIST) and Columbia University Law School in New York (FULBRIGHT SCHOLAR). He has twenty five years of experience in teaching constitutional law in Tribhuwan University. He is also extensively involved in legal research and consultancies on development and constitutional law matters. He is a Reader in the Faculty of Law (TU) and consulting legal advisor to many World Bank and Asian Development Bank projects and institutions such as Rashtriya Banijya Bank, Nepal SBI Bank and Nepal Airlines Corporation. He has an extensive practice in banking, corporate and business law as well. He has published more than 50 research articles in national and international law journals in the matters of constitutional law. He was a lead member in consultant drafting team for rules of procedure of constituent assembly. He has already contributed his views as a constitutional expert in most of the thematic committees of constituent assembly.

Pushpa Bhusal (Nepal)

Pushpa Bhusal is the member of Constituent Assembly from Nepali Congress. Hon. Bhusal is the leading advocate of the Supreme Court of Nepal. She is the General Secretary of Nepal Women's Association of Nepali congress. She was a member of Interim Constitution Drafting Committee 2007 as well as a member of Truth Commission Drafting committee.

Ramiah Yogarajan (Sri Lanka)

Ramiah Yogarajan is an Engineer by profession, with a Bachelor of Science degree specialising in Production Engineering. He was an entrepreneur in the Textile and Garments Industry with over 2000 employees and entered the field of politics through the Ceylon Workers Congress, which is a political party and trade union representing the Sri Lankan populace of recent Indian origin who were brought to Ceylon as plantation workers in the 19th century. This group of people have a distinct identity and issues typical to the group. He was a Provincial council member from May '93 to Oct 1994 and was elected to Parliament in Oct '94. He has served in the Parliament 1994-2004 and has re-entered in 2010 after the April elections. He has been the spokesman for the party and community in most forums discussing a political role for the community. In November, he quit the Ceylon Workers Congress (CWC) and joined the United National party, after he felt that the CWC was not articulating the needs of the Indian origin community in an effective way due to obligations as a member of the government alliance.

Sriyana (Indonesia)

Sriyana has a background education in Criminal Law and a Master Degree of Human Rights from The Hong Kong University. He also has a Diploma Degree in Forensic from Groningen University, Netherlands. He joined the Indonesian National Commission on Human Rights (Komnas HAM) in 1993. He is now the Head of the Division of Monitoring and Investigation

of Komnas HAM). He has extensive experience in studies and research, prepares draft of the law, conducts monitoring and investigation of human rights violations. In the area of public awareness, he also has experiences as a facilitator and resources person in human rights trainings.

Sudarshan Khadka (Nepal)

Sudarsha Khadka has a Master's Degree in both Public Administration and Economics. He is currently an Under Secretary (July 2002 - present) for the Committee for Protecting the Rights and Interests of Minority and Marginalized Community, Constituent Assembly, Public Accounts Committee & Women Caucus, Legislature-parliament. Prior to that, he was Section Officer at the State Affairs Committee, House of Representative. He has written many articles that were published in different daily national newspapers about the parliamentary and other current affairs.

Usha Kala Rai (Nepal)

Usha Kala Rai is a Member of the Constituent Assembly (Legislative Parliament) in Nepal. She finished M.Sc.in Botany, M.A in Sociology & Anthropology and LL.B. She was a former Professor in Tribhuwan University, Nepal. Her responsibilities in the Constituent Assembly includes: member of the Fundamental Rights & directive principle thematic committee; gender coordinator in the same committee; member of the Legislative committee; parliamentarian member in the National Development Council; member of the Advisory committee in CA and executive member of the Women Caucus-Constitution Assembly, Nepal

Yan-yan Yip

Yan-yan Yip is the Chief Operating Officer of Civic Exchange, an independent non-profit public policy think tank based in Hong Kong. She joined Civic Exchange in 2001 initially as project co-ordinator responsible for projects related to civil society development and constitutional reform. She managed many research projects focused on Hong Kong, Mainland China, and Asia, and continue to coordinate Civic Exchange's relations with many research and civil society organisations in and outside Hong Kong. Christie Warren (Curriculum Developer)

Dr Warren is Professor of the Practice of International and Comparative Law and Director of the Comparative Legal Studies and Post-Conflict Justice Program at William and Mary Law School. Her courses include Comparative Law, Comparative Constitutional Systems, Post-Conflict Justice and the Rule of Law, International Human Rights Law, Litigation in Civil Code Systems, Islamic Law, and Introduction to Common Law Methodologies.

Professor Warren has designed, implemented, monitored and assessed constitutional, judicial and legal development and training projects in 34 countries throughout Africa, Central and East Asia, Latin America and the Caribbean, Central and Eastern Europe, the Middle East, Russia and the Newly Independent States, the Balkans and East Timor. She was named the 1998 – 1999 Supreme Court Fellow at the Supreme Court of the United States and received the Supreme Court Fellows Alumni Association's Administration of Justice Award for "significant contributions to the international administration of justice."

Wachira Maina (Curriculum Writer)

Mr. Wachira Maina is a Kenyan constitutional lawyer, currently working as Senior Advisor, Coach and Head of the Governance and Legal Cluster of the Strategy and Policy Unit, SPU. in the Office of the President in Rwanda. Okumba Miruka is an international consultant with expertise on gender mainstreaming, strategic planning, participatory training, research and documentation.
